

INVITATION TO SUBMIT EXPRESSION OF INTEREST TO UNDERGO RECOGNITION OF PRIOR LEARNING (RPL)

The Mauritius Qualifications Authority (MQA) is inviting applications for RPL in the under-mentioned sectors of the economy.

RPL enables a person, who has acquired over the years skills and competencies outside the formal education and training system, to obtain a duly recognized qualification.

Thus, potential candidates having worked for at least three years in their respective sectors as listed below are invited to express their interest by completing an application form (available at the MQA Reception or which can be downloaded from the MQA website) to undergo RPL against National Qualifications available at level 2 to 4 of the National Qualifications Framework (NQF) in the following fields:

The duly filled in application form together with a copy of National Identity Card and evidence of at least three years working experience in the aforesaid fields should be submitted to the MQA by **Friday 28 September 2018**. Potential candidates will be subject to a screening exercise. Only those who upon satisfying the eligibility criteria for RPL will then be called to effect payment of a processing fee.
